## GENERAL CONDITIONS OF THE BID

1. A separate envelope must be used for each bid.
2. Posted Bids
  - a) Bids which have been posted prior to the closing date and hour but received after the closing date an hour and which do not carry the official stamp of the Post Office, indicating the time and date, or where the Postmaster has not certified the date and time received, shall be considered as late.
  - b) In the case of a dispute arising as to whether the bid was posted on time or late, only the date stamp of the Post Office is acceptable and not the stamp of a franking machine being used.
3. Samples must be forwarded on request only. Carriage of postage must be paid by the bidder. Bids must under no circumstances be included in parcels containing samples.
4. Bid prices and delivery periods will remain binding and open for acceptance for 90 days after the closing date of the bid.
5. Instructions to Bidders Form must be completed and submitted together with the bidders' original proposal. **Failure to submit Instructions to Bidders Form will render the bid invalid.**
6. Bidders who are unable to bid to specifications for goods are requested to bid for goods nearest to specifications, which they are able to supply and to submit full specifications for such goods.
7. Only the successful bidder will be notified, and a bid will be accepted either wholly or partly.
8. Bids should not be qualified by the bidder's own conditions.
9. If delivered by hand, the bid must be delivered at GIPF HOUSE, Cnr. Dr Kenneth David Kaunda & Goethe Street, Ground Floor, Reception.
10. GIPF has zero tolerance to fraudulent and corruption activities.
